

# ARCH CAPE SANITARY DISTRICT DRAFT MINUTES

Mr. Ron Schiffman called the meeting to order at 8:08 pm.

**Public Comment:** None.

**Agenda:** Add Tim Gardner billing appeal. Ms. Tindall moved acceptance of the agenda as amended which was seconded by Ms. Virginia Birkby. Motion carried. All in favor.

**Consent Agenda:** Pull minutes. Ms. Tindall moved acceptance of the consent agenda as amended which was seconded by Ms. Debra Birkby. Motion carried. All in favor.

## **Old Business:**

**Emergency Preparedness Purchases:** (Information) Mr. Chick reported the purchase of shovels, tarps and other items on the list and estimated that he should be finished next month. Storage will take place at the fire station and at the church. He said he would talk to someone at the church about access to our stored emergency supplies.

**Mixer Status:** (Information) The mixer is still being repaired by Flygt who waived their \$500 rental replacement fee. Mr. Chick expects the repaired mixer to arrive in October. He is looking to purchase a brand new mixer with a proper mounting bracket for installation which would carry a four (4) year warranty and will make a recommendation to the board.

**Smoke Testing / Inflow Report:** (Information) Mr. Chick reported that he had been in discussions with the home owner of the rain water collection system connected to the district and will update the board at the next meeting.

**New Business:**

**August 18, 2017 Minutes:** Ms. Virginia Birkby moved acceptance of the minutes which was seconded by Ms. Tindall. Motion carried. All in favor except for Ms. Debra Birkby who abstained.

**Billing Relief Request – 80090 Pacific Ave:** (Action)

Mr. Chick provided case background that included that Mr. Davis' water meter showed usage of over 51,000 gallons usage for the month of July, 2017, contributing to excess usage charges of \$5,094.85 on his quarterly bill. Meter data readings showed likely high levels of irrigation water use in the early morning hours of approximately 2,000 gallons per day. Mr. Davis did not have an irrigation maintenance report turned in, that is due May 1<sup>st</sup> annually, on file for the current or past years. Requirement notices had been provided to the customer along with his quarterly billing and in a letter mailed to homeowners with irrigation systems. Mr. Robert Davis presented his appeal. He reported that he may not have received such a letter due to his seasonal residence outside of Oregon and the increased possibility of missing mail. Mr. Davis also expressed his belief that not having an irrigation report on file should activate the Board to notify an owner of that fact; that he supports the Board and is a good property owner. He further stated that there should be some method in the District to flag high water usage to customers and should be monitored better or more timely. Mr. Davis submitted his appeal for billing relief for excess sanitary usage charges (attached) resulting from 51K plus gallons of metered usage in July of this year. Ms. Virginia Birkby moved to deny the appeal in its entirety which was seconded by Ms. Tindall. Motion failed. All voted no.

There followed a discussion as to the effect of the prior motion and vote at which point Ms. Virginia Birkby offered a new motion that the appeal be granted in part with a reduction in the billing for the highest tier amounting to \$3,927.00 which was seconded by Ms. Tindall. Motion carried. All in favor.

**Billing Appeal Request – 32001 E. Shingle Mill Lane:** (Action)

Mr. Chick provided case background that included Mr. Gardner's August 2017 meter reading that included excess usage of 166,700 gallons and excess charges of \$23,033.75. Mr. Chick reported that Mr. Gardner had submitted his irrigation report this year, was a relatively low user of water, and had maintained his account in paid up status. A credit memo under the existing leak policy had been issued. Mr. Tim Gardner presented his appeal and requested that the entire \$850.17 in excess usage charges be waived. The leak on his property resulted from a failed pipe connection in his irrigation system which he has subsequently repaired. Mr. Gardner said it was his intention to take his irrigation system out of service by capping the incoming water service pipe and thanked Mr. Chick for providing him notice of the water leak.

Ms. Virginia Birkby moved and Ms. Debra Birkby seconded to deny the appeal in its entirety. Discussion of the motion ensued. Motion carried. All in favor.

**Election of Vice-President:** (Action) Ms. Tindall moved the election of Ms. Virginia Birkby as Vice-President which was seconded by Ms. Debra Birkby. Motion carried. All in favor.

**Reports:**

**Accounts Receivable:** A/R was reported in good condition with one new customer hookup for the district.

**District Manager's Report:** (attached) Two of the phone lines had been switched over from Century-Link to Charter as well as Charter now providing internet access.

**Treasurer's Report:** The LGIP account was reported at \$272,235.81 and Columbia Bank at \$111,601.95. Treasury management is scheduled to transfer to PFM on October 1<sup>st</sup>.

**Board Comments:** Ms. Virginia Birkby said that a policy framework had been built which is working for the board. Ms. Tindall said that her recent invoice was relatively light. Ms. Debra Birkby expressed her hope there would be talk amongst neighbors concerning irrigation use.

**October Agenda Items:** Emergency preparation update, mixer status, smoke test update, district letterhead, best practices checklist and executive session on attorney's advice on a system hookup for DeBlasio.

**Public Comment:**

Mr. David DeBlasio introduced himself to the board. He said that he would like to give input to the board following their review with district counsel. He added that in valuing the timbered watershed land that a 'cruise for value as salable' could be undertaken that could help establish a sale price. He expressed his hope that he might in future provide additional information to the board regarding his position on hooking up to the district (attached).

David and Jeannie Stockton complimented the Board on their work.

The meeting was adjourned by Mr. Schiffman at 9:12 pm.

The following are my reasons for my appeal.

I was informed by Phil Chick by phone on August 8th. that my water usage for July was going to be approximately 51,000 gallons

He also told me that they did not have on file a signed copy of the Arch Cape Water District's Policy dated January 10, 2014.

I informed him that I had not received a copy of the letter.

We spend our winters in California due to my health and have our mail forwarded to us. Possibly this could be the reason I did not receive any notice.

After going on line to Arch Cape.com I was able to secure a copy of the Arch Cape Water District Policy.

Enclosed is a copy of this policy signed and for your files.

After Phil's call, I immediately had my RainBird unit checked for usage and had Dennis 7 Dees Landscape check for any leaks.

The results were that I had a bad controller; dispersing water during the early hours of the morning; 2:30am.-4:30am. and I had three line breaks in the yard. These breaks were in my drip system.

This combination explained the excessive usage for July.

Dennis 7 Dees Landscape has installed a new RainBird at their cost to me; and has repaired the damaged lines.

Enclosed is a copy of their invoice.

I can assure the Board that Dennis 7 Dees Landscaping and I will be in compliance with your policy on the management of water use in Arch Cape.

## Water Leak Appeal Request

Tim Gardner

A bit before noon on August 30, 2017 I received a call from Phil Chick telling me I had a water leak on my property. I drove to Arch Cape from Portland and met Phil at my home at 1:45 pm. By the time Phil arrived I had the soil cleared from the area around the leak. Phil pointed out the leak to me. A glue joint on the supply side of the irrigation system shut-off valve had come loose. (Please see attached pictures)

I was very surprised at the finding. The irrigation system was installed at least 26 years ago. I've owned the house for 24 years and have no problems and no work done on the system. The backflow device has been tested annually and all required tests / reports have been submitted to the Water Service District as required.

Upon further investigation, it's clear that the PVC pipe that failed was only pushed half way into the threaded coupler when it was initially installed. It's amazing that this glue joint survived at full system pressure for all that time.


My plan moving forward is to replace the shut-off valve and associated PVC piping – assuring all joints are fully seated. I will no long leave the water on to my property when the house is unoccupied. This has typically been my practice in the past – except during the summer. In the future, I will only run the sprinkler system when I'm present and the water will be off the rest of the time.

I'm asking for relief since there is no way I could have known that the glue joint was defective. The glue joint that failed was underground well outside any traffic area. It was a defect at the time of installation 26 years ago.

I've also attached a "not so easy to read" record of my monthly water usage report. In the time I've owned the house I believe I've gone over the 5,000 gallon normal usage limit 1 time - June 2014. This was due to a leak in the packing of the shutoff valve to the house – when the shut-off valve was in the closed position. Rarely do I use over 2,000 gallons / month with a typical month being below 1,000 gallons.

I will show Phil the final repair on or after after September 9, 2017.




